President Bob Crosby recognized Past President Jim Lawrence for dedicated work and presented him with a gift of appreciation.

President Bob Crosby noted the following action items to the general membership:

- A. The membership list is now posted on MISCA.NET
- B. The newsletter will only be published on MISCA.NET it will not be mailed out.
- C. MISCA now has eight zones, not seven. Zone information can be found on MISCA.NET
- D. MISCA.NET will also have a state top-40 listing, but it will only be successful if coaches submit times on a regular basis.

Reports to Membership

Treasurer's Report:

Secretary-Treasurer Brian Bollone reviewed the financial status of MISCA and briefed the membership on the increased growth of the organization over the last year. Currently, MISCA has \$25,432.00 in checking and \$7.75 in savings. This net total is approximately \$2,750.00 more than a year ago.

Last year, MISCA had a record high membership, 329 members- up 21 from the 2000-2001 calendar. Already this year, the membership is at 182.
