 - Use grade numbers (9, 10, 11, 12), not letters
 - Please enter coaches name and contact information
 - Coaches are asked to double check and update your data base
 - Jan Cartmill reported to Denny: US Swimming needs official first name and birthdate. You do not need the USS #.
